CODE OF CONDUCT TRAINING

Bring Your Code, and Your Corporate Values, to Life

The foundation of an effective compliance program is rooted in a strong values-based Code of Conduct. Incorporated into that Code are the seven Office of Inspector General (OIG) elements, recommendations of the US Sentencing Guidelines and major health care compliance tenets. To implement more sophisticated compliance programs, our solution focuses on an integrated compliance learning model. Through this model, compliance officers can identify high-risk employees and nonemployees, and then deliver the Code of Conduct and ensure an auditable receipt. We mange this via the Forms Monitor tool in ComplianceWire which tracks an employee's response and triggers an automated email based on their answers. This email can be sent to a designated individual so they can take an appropriate specified action. The email can also be routed to a manager so that they can confer with the employee in question.

The Forms tool allows you to be the author of your Forms which is useful for creating your annual Conflicts of Interest statements and for attestations from FDRS/Consultants.

Forms monitor, a tool within the Forms tool, notifies you if someone responds in a

way where you need to do an investigation. The form can be appended with the results of the investigation which is essential for audits.
