## Unique Partnership with the US FDA



Since 1999, UL has maintained a unique partnership with the US FDA. Under a technology Cooperative Research and

Development Agreement (CRADA), UL provides the online training, documentation and CFR 21 Part 11-validated technology system, ComplianceWire®, for "ORA U," the Agency's Office of Regulatory Affairs virtual university. To date, more than 36,000 federal, state, local and global inspectors have used ORA-U for their onboarding and ongoing training management, including online, instructorled, on-the-job and other credentialing requirements. In addition to the technology, UL has converted much of ORA's classroom education into online programs for consistent and global delivery over the internet. Using this technology-based solution, the Agency has reported that the average investigator orientation time has been reduced by more than nine months. That same solution is available to UL's Pharmaceutical, Biologics and Medical Device clients.



### **Award-Winning Technology**

UL's ComplianceWire technology is an enterprise-wide learning management system specifically designed for the regulated learning and training requirements of Life Science organizations. Designed to meet 21 CFR Part 11 and EU Annex 11 requirements, the technology supports the quality and validation constructs as defined by Good Automated Manufacturing Processes (GAMPs) and Good Manufacturing Practices (GMPs) as specified in CFR 820 (Quality Systems Regulations). ComplianceWire uses a cloud-based model, thereby reducing IT and validation costs, and ensuring rapid deployment by clients for the dissemination, monitoring, documentation and reporting of SOPs, corporate policies, regulatory information, in-person training and compliancemandated education.

Available in 34 languages, including Hindi, ComplianceWire has received the coveted Brandon Hall Award for four consecutive years for technology excellence in the Compliance Training category.
