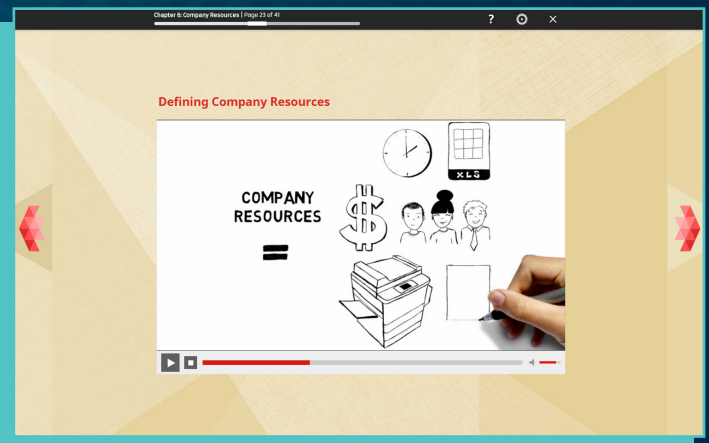

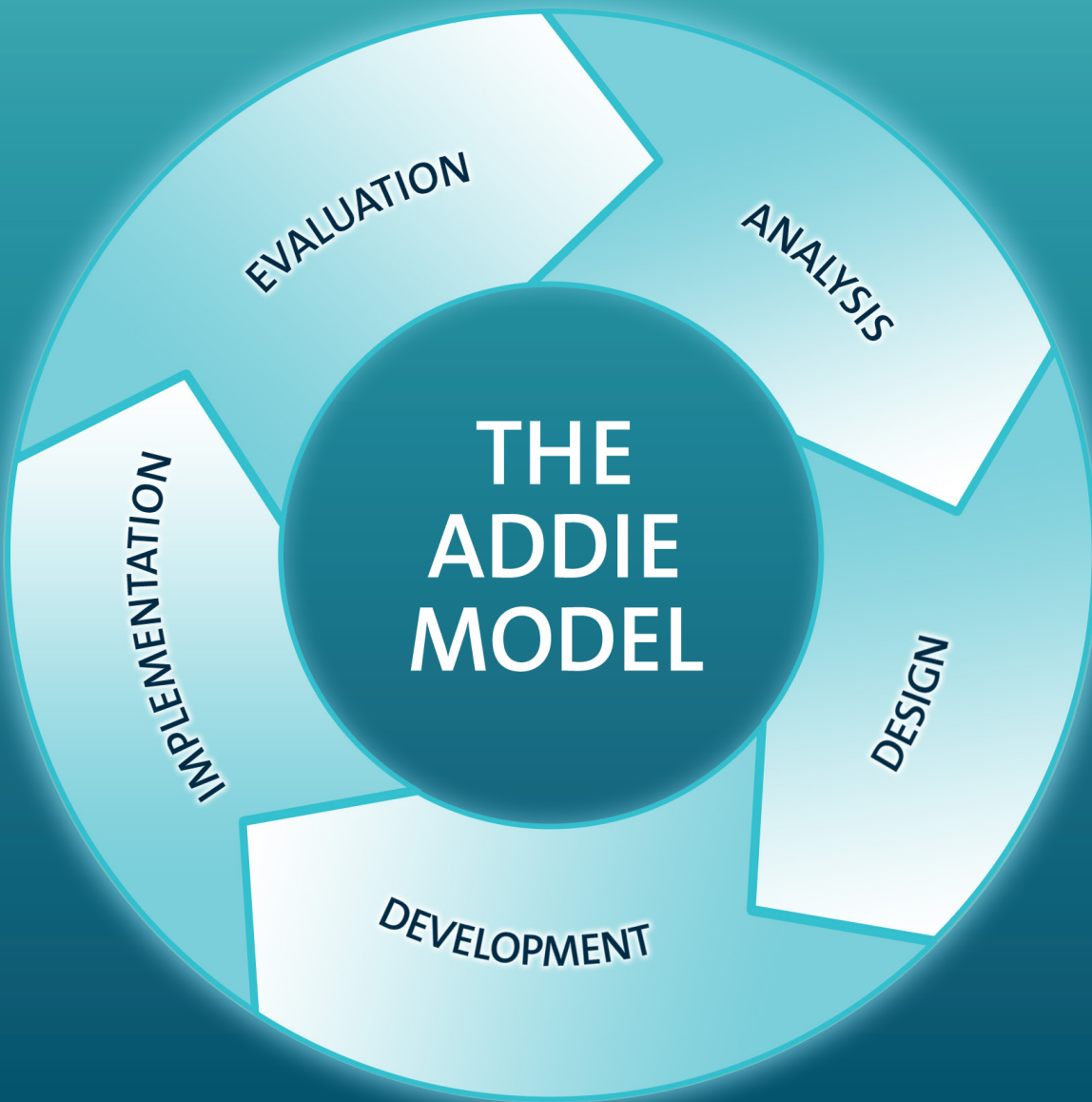
Course Planning

- We also apply the ADDIE model of ISD: Analysis, Design, Development, Implementation and Evaluation.
- We use proven project management techniques to ensure a course is delivered on time and within budget.
- During course development, our instructional designers work collaboratively with your Subject Matter Experts (SMEs) or existing text or presentation materials to understand the audience and define the course objectives.
- We ensure the content of a course does not exceed the appropriate reading level for the intended audience.
- Our course designers incorporate instructional and interactive elements into the course content to transfer the knowledge and skills learners need to become qualified on the course topic. With the help of the SMEs, we add realistic scenarios and other activities so that the learners can practice the knowledge and skills to facilitate “deep processing” of the information.



Course Engineering

- Our next generation course player supports both mobile & desktop delivery. One course for all delivery approaches.
- Our courses are instructionally engineered for effective, interactive and self-paced learning. We apply the right kind of interaction based on our inventory of engaging learning activities, as well as avatars, white board animations, and branching, each designed to promote proficiency in specific knowledge and skill categories.

- Courses can be translated into multiple languages to meet the needs of global organizations. For ComplianceWire subscribers, a course can be presented in up to 34 languages.



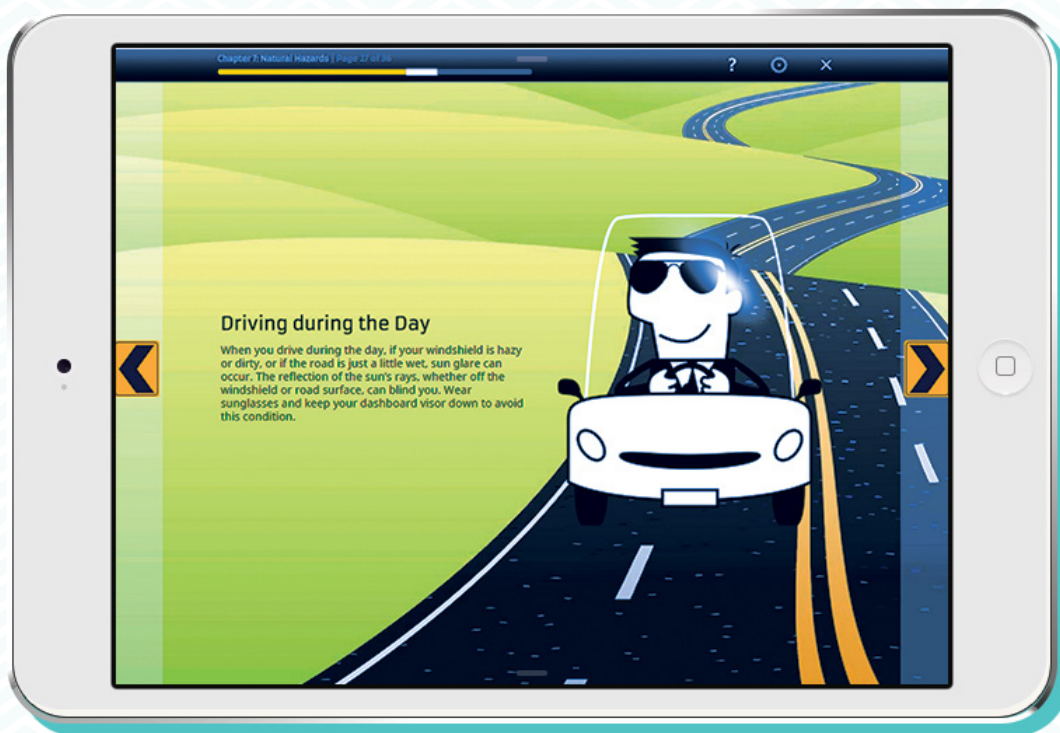
Courses are developed using a Mastery Learning approach, which requires learners to interact with the content and demonstrate proficiency before they can advance through the course.

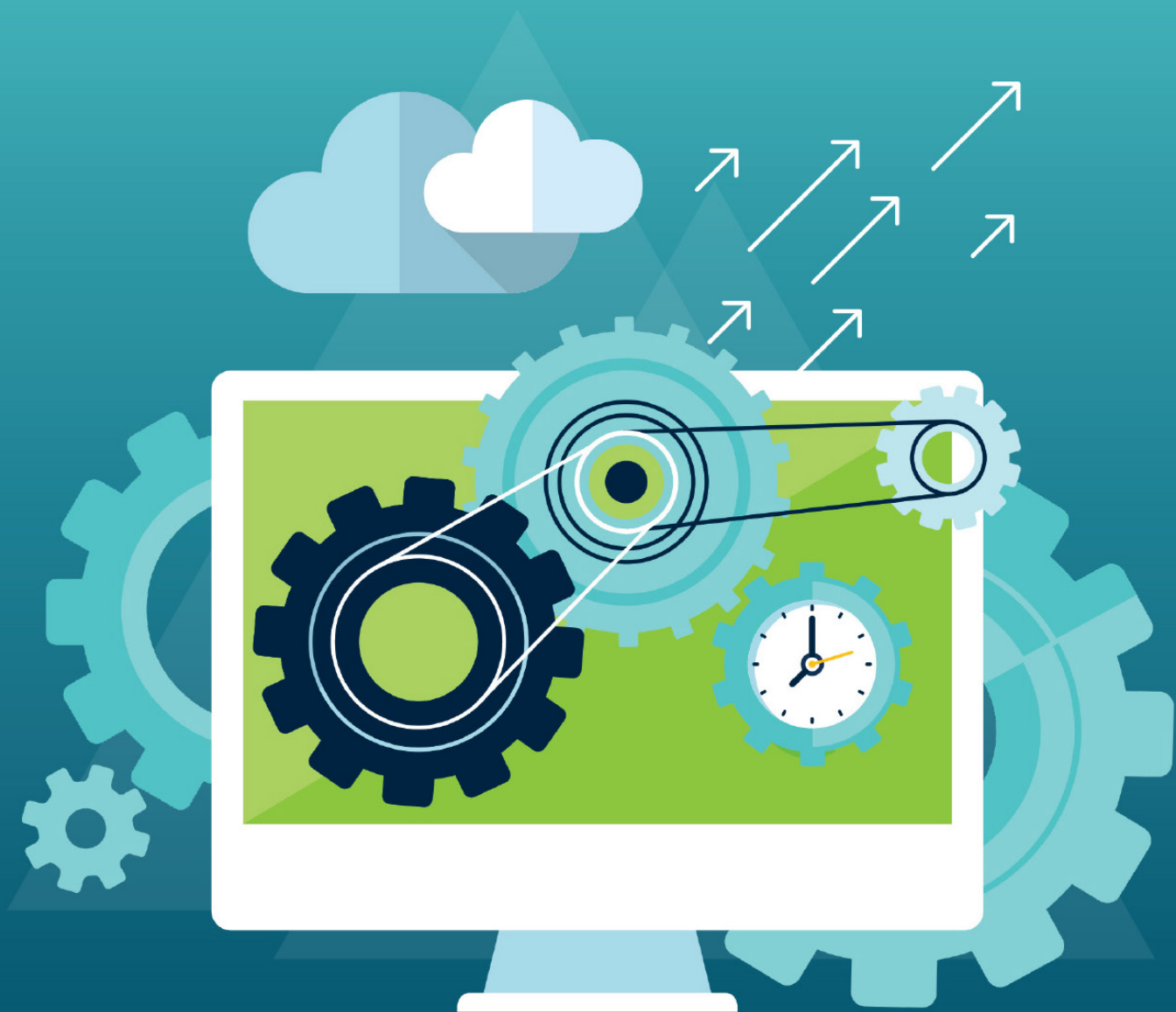
